A bold commitment has been made by 4-H to youth across the country to reflect the diverse needs, vulnerable populations, and different social conditions experienced by all ages. With this initiative, Extension professionals are given the opportunity to work with different cultures including that of our First Nations. With this opportunity comes an initial obligation to learn about the differing cultures, social ecosystems, and sacred history of the

tribes they work with. The diversity of cultures within the American Indian/Alaskan Native (AI/AN) are unique in their own way and an equity lens will help Extension professionals understand specific conditions when planning 4-H programming with Indigenous communities.

AI/AN youth are faced with multi-faceted conditions that can have an impact on their development and participation in activities. This is a

result of several programming options catering to the "majority" of cultural expectations versus options being available to the cultures and ecosystems of the First Nations. These Native communities are very close knit and have been since time immemorial. With an effort put forth by the 4-H Program Leaders Working Group and efforts by FRTEP (Federally Recognized Tribal Extension Program), 4-H and involving the AI/AN youth communities is an important area of focus, with hopes to bring more programming to different tribes across the country.

After considering these circumstances, it is important to have positive social conditions within any programming delivered because there are many challenging aspects which exist amongst AI/AN youth in their communities. AI/AN have the highest poverty rates in the nation as well as elevated high school dropout rates. AI/AN youth tend to be geographically isolated as well, so this should also be considered when planning programs for the youth. An awareness should be developed by the program leader to understand the cultural/social

identities, values, stereotypes, experience of privilege and oppression, and how they shape ones view on mental health and well-being. With this, it will help them lead programming efforts with a more empathetic and cognizant approach.

Through FRTEP, Extension Directors are responsible for an extremely diverse programmatic portfolio including Agriculture & Natural Resources (ANR); Family,

Consumer, and Health Sciences (FCHS); Community Economic Development (CED) and/or 4-H Youth Development. The specific inclusion of Native American programs, where Tribes exist within their state service area, is a critical piece of the land grant mission and encompasses the unique geographic, cultural, and economic challenges of delivering Extension programs in Indian Country. Having a clear understanding of the Federally Recognized Tribal Extension

Programs (FRTEP) and its vital role it plays in effective Indian Country Extension will enable Extension Directors to properly fulfill the Cooperative Extension mission for all citizens of respective states.

After discussing the challenges and awareness needed to deliver effective 4-H programming to AI/AN communities, a vital factor is to develop the sense of belonging for the youth participating in the programming.

"The Peoplehood Model (Holm et al., 2003) provides insight into AI/AN culture, emphasizing the importance of cultural histories, places, ceremonies and languages. The Peoplehood Model refers to shared backgrounds, histories and common experiences which individuals and groups can reference. There is a developing Extension practice and literature incorporating these themes of identities into PYD (Farella, et al., 2021; Farella, et al., 2021)."

The Peoplehood Model (Holm et al.,2003) provides a good framework for working with AI/AN youth. Other positive practices to develop the sense of belonging and

The 2024 4-H Horse Judging Contest for Washoe and surrounding counties will be on April 6, 2024, starting at 9 a.m., Ironwood Events Center, 5600 Whiskey Springs Road, Reno, NV 89510. The contest is open to all 4-H Horse Project members in Washoe, Carson/Storey, Douglas, Lyon, and Churchill counties.

There are five age groups: Adults and Cloverbuds



(for fun and experience), Juniors, Intermediate, and Seniors. There will be two halter classes, two performance classes, reasons on one of the halter classes and one of the performance classes, and Tack ID and Feed ID classes.

Ribbons will be awarded to the top four in each age division.

Java Reef will have a food truck on site with several coffee and breakfast offerings, sandwiches, and salads for lunch.

increasing participation is to develop 4-H projects around current AI/AN topics and culturally significant topics. Some of these may be:

- Tribal food sovereignty
- Tribal entrepreneurship and Native arts entrepreneurship
- Social justice issues important to specific tribal communities
- Sustainable livestock and farming practices on tribal land

Once 4-H programming is delivered to the First Nations Youth, it will be important to follow up, evaluate, and continue to grow 4-H's presence. When evaluating programming efforts, language and wording should reflect common AI/AN words, themes, and thoughts. Community members, First Nation governments, and other organizations should also share in the dialogues of these initiatives. Remembering community questions should have community answers. With these collaborative efforts, commitments and evaluations, 4-H programming will hopefully become a well-known positive youth development representing equality, acceptance and growth for American Indian/Alaska Native youth across the country.

#### **Diamonds in the Rough**

The Diamonds in the Rough Novice Horse Show, is April 20, 2024. It's presented by Silver Knolls Spurs 4-H Club of Washoe County, and will be at the Lemmon Valley Horsemen's Arena, at the corner of Chestnut and Alaska in Lemmon Valley.

The show office will open at 7:30 a.m. with the classes starting at 9 a.m. There will be a snack bar. Water will be provided.

This is an open show offered specially for the novice rider, the novice horse and the green horse. There will be over 40 classes offered.

A Novice Rider/Showman is a rider/showman who has not won more than three blue ribbons in a particular kind of class. No age restrictions.

A Novice Horse is a horse that has not won more than three blue ribbons in a particular kind of class. A Green Horse is a horse not shown in a particular kind of class before January 1 of this year. An experienced rider may show a green horse. No age restrictions on the horse.

Required attire includes a helmet (required for all exhibitors 18 years or younger), long sleeve shirt and/or jacket, or club shirt long pants with belt and riding boots. Chaps and spurs are optional. "Show" clothes are not required.

If you are not a 4-H Leader or other screened individual, please register as soon as possible. Only adults who have completed a background check and references are allowed to be Chaperones. The background check will often take 4-6 weeks.

Camper Registration forms will go out May 1, to 4-H members who will be 9-12 years of age on the first day of camp (July7). Only 4-H member registrations will be accepted until May 16, when registration is open to the general public.
